The recognition becomes effective only upon delivery of the certificate of recognition to the applicant. the applicant.</p> <p>In order to be recognized as a mine surveyor, you must</p> <ul style="list-style-type: none"> <li>* the qualification for the higher civil service in the field of mine surveying,</li> <li>* the reliability required for the activity of a mine surveyor, and</li> <li>* the physical and mental aptitude required for the work of a mine surveyor, and</li> <li>* have not yet reached the age of 70.</li> </ul> <p>Persons who have passed an examination as a mine surveyor outside the Federal Republic of Germany may be recognized as mine surveyors if</p> <ul style="list-style-type: none"> <li>* the training and examination correspond to the type and scope of training and examination for the higher civil service in the Federal Republic of Germany, and</li> <li>* the Ministry of Economics confirms the equivalence.</li> </ul>

If the training and examination are not equivalent, recognition may be made dependent on completion of supplementary training and passing of an additional examination.

The recognition of other persons for the preparation of other documents of the crack work can only take place company-related.

The application for recognition as a mine surveyor must be submitted in writing to the Stralsund Mining Authority. The recognition procedure may be handled by a single office in accordance with Section 1 (1) of the Single Point of Contact Establishment Act. § Section 42a of the State Administrative Procedures Act on the deemed approval shall apply with the proviso that the period pursuant to Section 42a (2) of the State Administrative Procedures Act shall commence upon receipt by the Stralsund Mining Authority of the certificate of good conduct to be applied for pursuant to subsection (3) number 4.

**Formulare + Objekt** You must submit a written application to the competent body. You will receive a certificate of recognition.

Recognized mine surveyors and other recognized persons are subject to the reporting obligation pursuant to Section 14 of the Mining Ordinance of December 1986. in accordance with § 14 of the Mining Ordinance of December 19, 1986. annual report can be found on the Internet.
