Volltext	For the transfer of a corpse within the Federal Republic of Germany, a mortuary passport is generally not required. If a passport is required by the federal state to which the corpse is to be transferred, the health offices will issue it upon request. Before a corpse from Mecklenburg-Western Pomerania may be transferred abroad, a second (official) post-mortem examination is required. Further information can be obtained from the health authorities, which also issue the passport required for the repatriation. When transferring a corpse abroad, the legal regulations of the countries of destination and transit must also be observed. Kosten	The fees for the issuance of a mortuary passport are derived from the
Verfahrensablauf	A multilingual mortuary passport must always be applied for in person at the health office. However, you can also instruct the funeral home responsible for the transport to apply for the mortuary passport at the health office. The mortuary passport may only be issued when the documents required for a burial are available and, in the case of transfers abroad, the second post-mortem examination has been carried out.
