If the death has not yet been recorded, proof from the registry office that the death has been reported there. The deceased may only be cremated prior to notification to the registry office with the approval of the regulatory authority of the place of death. • Written instructions from the deceased or relatives that cremation is to take place

Verfahrensablauf	A second (official) post-mortem examination is required before cremation. The second post-mortem examination is carried out by a specialist in forensic medicine or a doctor from the public health department at the crematorium. The doctor will issue a

	<p>certificate confirming the results. Cremation may only take place if there are no indications of a non-natural death or if the public prosecutor's office has given its consent. Further information can be obtained from the health authorities.</p>

Hinweise	<p>If the deceased has expressly requested cremation, his or her wishes must be complied with. If they have refused, cremation is not permitted.</p> <p>A handwritten directive can read as follows: "I, (first name and surname), wish to be cremated after my death. Place, date, signature."</p> <p>If this testamentary disposition for cremation is missing, the next of kin can make a corresponding disposition.</p>
