Teaser	You would like to collect non-profit or commercially recyclable waste from private households? Then you must notify the competent body at least three months before the start of the collection.
Volltext	<p>You must notify non-profit and commercial collections of recyclable waste from private households at least three months before the collection begins. Notification is required, for example, for street or container collections of textiles and shoes, but also purchase points for waste paper, scrap metal or similar.</p> <p>The collection may be prohibited, limited in time or subject to conditions by the competent authority.</p> <ul style="list-style-type: none"> <li>• Waste (including recyclable waste) from private households must regularly be handed over to the public waste management authorities (obligation to hand over waste).</li> <li>• Exceptions to this obligation are, among others, commercial or non-profit collections of recyclable waste, if these have been notified to the competent authority;</li> <li>• notified collections may be prohibited or restricted by the competent authority</li> </ul>

	<ul style="list-style-type: none"> <li>• Mixed waste from private households as well as hazardous waste may not be collected on a commercial or non-profit basis</li> </ul> <p>Electrical waste (defective old electrical appliances) and batteries must be handed over to the public waste management authority or returned to the dealers who are obliged to take them back Non-profit or commercial collection is prohibited.</p>
Erforderliche Unterlagen	<p>In the case of commercial collections:</p> <p>Information on the size and organization of the collection enterprise, on the type, extent and duration, in particular on the largest possible scope and the minimum duration of the collection, on the type, quantity and whereabouts of the waste to be recovered, a statement of the intended recovery routes and how recovery is ensured.</p> <p>In the case of non-profit collections:</p> <p>Information on the size and organization of the body responsible for the collection and, if applicable, of the person in charge of the collection, as well as on the type, extent and duration of the collection, proof of the non-profit status of the collector The same scope of documents as for commercial collection may also be requested.</p>
Voraussetzungen	<p>The purpose must be a collection of waste from private households for commercial or charitable purposes.</p> <p>The collection must not be opposed by an overriding public interest.</p>
Kosten	<p>The Thuringian General Administrative Costs Regulations provide for a fee range of at least 5 euros to a maximum of 50000 euros.</p>

Bearbeitungsdauer	<p>If the complete documents are available: 3 months</p>

Frist	The complete notification must be submitted no later than three months before you plan to start collecting.

Hinweise	Anyone who fails to report a charitable or commercial collection, or fails to report it correctly, completely or on time, commits an administrative offense. This can be punished with a fine of up to 10,000 euros.

Kurztext	<ul style="list-style-type: none"> <li>• Non-profit and commercial waste collections must be notified to the competent authority in due time (3 months before the start of collection).</li> <li>• Certain documents must be submitted.</li> <li>• The procedure is subject to a fee.</li> <li>• Responsible: The Thuringian State Office for the Environment, Mining and Nature Conservation (TLUBN) as the upper waste authority.</li> </ul>

Formulare	<p>The notification can be made informally by enclosing the documents specified in Section 18 (2) or (3) KrWG.</p> <p>The form included in the appendix requests the relevant information so that nothing is forgotten and processing is delayed due to incomplete documents. The use of the form is therefore recommended.</p>
