Teaser	You must notify the competent body of the temporary and occasional exercise of the activity as a dentist within the framework of the provision of services under European law.
Volltext	If you are a national of a member state of the European Union (EU) or of another contracting state of the Agreement on the European Economic Area (EEA) or of a contracting state to which Germany and the European Community (EC) or Germany and the EU have contractually granted a corresponding legal right entitling you to practice the profession of dentistry in one of the other member states of the EU, the EEA or a contracting state, you may temporarily and occasionally practice your profession of dentistry in

Thuringia within the scope of the provision of services. You do not need an Approbation/Professional Licence for this. However, you are obligated to notify the responsible Thuringian State Dental Association in writing in advance of the intended practice of your profession. The notification must be renewed once a year if you intend to provide services temporarily or occasionally during the year in question. The notification has to be made before starting the activity, in urgent cases the notification can be made up immediately.

Erforderliche Unterlagen

If you are providing the service for the first time or if there has been a significant change from the situation certified in the documents, submit the following documents to the Thuringian Dental Association:

- The proof of your citizenship,
- your proof of professional qualification, if applicable, proof of further dental education and, if applicable, title certificates,
- a current certificate stating that you are legally established as a dentist in the other member state or contracting state, that you are not prohibited, even temporarily, from practicing this profession at the time of submission of the certificate, and that you have no criminal record,
- information on the nature and duration of the intended temporary and occasional activity,
- evidence of adequate professional liability insurance or collective protection with respect to professional liability; and
- a statement that you have the knowledge of the German language required to provide the service.

The documents must be submitted in the form of originals or certified copies. As a rule, your documents must be submitted in German or as a certified copy of a German translation. The translations must be made by interpreters or translators who are publicly appointed or sworn. The translations must be made from the original or from the certified copies. This must be certified by the translator.

	<p>If you submit your application electronically via the Single Point of Contact, only documents issued or recognized in a Member State of the European Union or another State party to the Agreement on the European Economic Area can also be submitted electronically. If the competent authority has reasonable doubts about the authenticity of the transmitted documents, it may request the submission of certified copies.</p>
Voraussetzungen	<p>You are a national of a member state of the EU, the EEA or another contracting state.</p> <ul style="list-style-type: none"> • You are legally established as a dentist in another member state of the EU, the EEA or a contracting state. • You wish to exercise your profession as a dentist temporarily and occasionally in Thuringia within the framework of the provision of services. • You are not prohibited from practicing this profession, even temporarily, at the time of registration with the Thuringian Dental Association. • You do not have a criminal record. • They have the knowledge of the German language required for the provision of the service.
Kosten	<p>The registration is free of charge. There are also no membership fees.</p>
Verfahrensablauf	<p>For the intended temporary and occasional practice of dental services, you must notify the Thuringian Dental Association in writing before commencing the activity and submit to the Chamber the certificates and attestations required for the provision of the service. The temporary and occasional nature of the provision of services will be assessed on a case-by-case basis. The decision will take into account the duration, frequency, regular recurrence and continuity of the service. You will receive written confirmation of your notification.</p>
Bearbeitungsdauer	<p>The processing time is up to 2 weeks once your documents are complete at the responsible chamber.</p>
Frist	<p>The notification must be made before the start of the activity; in urgent cases, the notification can be made</p>

Hinweise	<p>When providing services, you have the same rights and obligations as chamber-affiliated dentists. You are subject to the professional, legal and administrative rules of professional conduct and the applicable disciplinary regulations.</p> <p>If you wish to practice your profession as a dentist in Thuringia on a permanent basis, you need a license to practice. Whether the activity is temporary and occasional is assessed on a case-by-case basis. If this is not the case, you must apply for an Approbation.</p>
