Teaser	Would you like to work as a nurse in Germany? Then you need a state permit. To obtain a state permit, you must submit an application and have your foreign professional qualification recognized.
Volltext	<p>The nursing profession is regulated in Germany. This means that in order to work as a nurse in Germany, you need a state license. With this permit, you can use the professional title "Pflegefachperson", "Pflegefachfrau" or "Pflegefachmann" and work in the profession.</p> <p>You can also obtain a state permit from the competent authority in Germany if you have a professional qualification from a so-called third country. Third countries are all countries that do not belong to the European Union (EU), the European Economic Area (EEA) or Switzerland. In order to obtain the permit, you must have your foreign professional qualification recognized. In the recognition procedure, the competent authority will compare your professional qualification from abroad with the German professional qualification and check its equivalence. The equivalence of the professional qualification is an important prerequisite for the granting of a state license.</p> <p>You can also waive the equivalence check and complete a knowledge test or an adaptation period directly. In this case, the competent authority will not carry out an equivalence check.</p> <p>In addition to the equivalence of the professional qualification, you must also meet other requirements</p>

for the permit to be issued. Further requirements include, for example, sufficient German language skills and health suitability.

If your professional qualification originates from the EU, the EEA or Switzerland, other regulations apply. You can also apply for the procedure from abroad.

Erforderliche Unterlagen

The responsible office will tell you which documents you need to submit. Important documents are generally

- Proof of identity (identity card or passport)
- Marriage certificate (if your name has changed due to marriage)
- Curriculum vitae
- Proof of your professional qualifications (e.g. certificates, professional certificate)
- Proof of training
- Proof of your relevant professional experience in a profession comparable to that of a nurse
- Proof of other relevant knowledge for working as a nurse
- Information about an application for recognition that has already been submitted. Then state the body to which you have submitted the application
- Proof that you wish to pursue gainful employment in Germany
- Do you still live or work in a third country, i.e. not in the EU, EEA or Switzerland? Then you may need to prove that you have received a commitment from a health and care facility to work as a nurse in Germany.

You usually submit these documents later. The responsible office will inform you when you should submit the documents:

- Proof of your personal suitability: criminal record extract or certificate of good conduct from your country of origin.
- Proof of your health suitability: Medical certificate.

- Proof of your German language skills: Language certificate

The responsible office will tell you which documents you need to submit as a simple copy, a certified copy or the original.

Voraussetzungen

- You have a comparable professional qualification as a nurse from a third country.
- You want to work as a nurse in Germany.
- Personal suitability: You are reliable to work as a care professional and have no criminal record.
- Health suitability: You are mentally and physically fit to work as a nurse.
- You have German language skills at the required level. This is normally language level B2 according to the Common European Framework of Reference for Languages (CEFR).

Kosten

The procedure costs money. The responsible office will inform you about the costs. The costs often depend on the effort required for processing.

The fee range is at least 80.00 Euro to 590.00 Euro.

Additional costs may arise (e.g. for translations, certifications or compensatory measures).

These costs vary individually.

Verfahrensablauf

****Application****

You submit an application to the competent authority for permission to use the professional title "Pflegefachfrau" or "Pflegefachmann", or you apply for the professional title "Pflegefachperson".

You can submit the application with the documents to the competent authority, send it by post or upload it electronically. Do not send any originals.

****Examination of equivalence****

The competent body will then check whether you meet all the requirements. An important requirement is the equivalence of your professional qualification. The competent authority will compare your professional qualification with the German professional qualification as a nursing specialist. The professional qualification is equivalent if there are no significant differences between your professional qualification and the German professional qualification.

You can also waive the equivalence test and complete a knowledge test or an adaptation period directly. In this case, the competent authority will not carry out an equivalence check.

****Possible results of the examination****

If your foreign professional qualification is equivalent, it will be recognized. The competent authority can confirm the result in writing. You must still meet the other requirements. You will then receive permission to use the professional title "Pflegefachperson", "Pflegefachfrau" or "Pflegefachmann".

Are there any significant differences between your professional qualification and the German professional qualification? You may be able to compensate for the differences through your professional experience, other knowledge, skills or competencies (lifelong learning). Knowledge, skills and competences must be certified by an authority in the country in which you acquired the knowledge, skills or competences.

However, it may be that the significant differences cannot be compensated for by your professional experience, knowledge, skills or competences. In this case, the competent authority will inform you of the significant differences between your professional qualification and the German professional qualification and why you cannot compensate for these significant differences.

The competent authority will also tell you what compensatory measures you can take to offset the significant differences.
If you decide not to take compensatory measures, your professional qualification will not be recognized and you will not be allowed to work as a nurse in Germany.

****Compensatory measures****

There are various compensatory measures:

- Adaptation course: The adaptation course lasts a maximum of three years.
- Knowledge examination: The knowledge examination tests your knowledge in certain subjects and areas. The knowledge test comprises an oral and practical part.

You can choose between an adaptation period or a knowledge test, even if you choose not to take an equivalence test.

If you successfully complete the compensation measure and meet all other requirements, you will receive permission to use the professional title "Pflegefachperson", "Pflegefachfrau" or "Pflegefachmann".

Bearbeitungsdauer

4 Monat(e)

The responsible office will inform you if any documents are missing. If the documents are complete, the procedure will take a maximum of 4 months.

Frist

There is no deadline. Sometimes documents are still missing from the procedure. The responsible office will then inform you by when you must submit the documents.

****Notification of equivalence****

The equivalence check is always carried out during the approval procedure (recognition procedure). You can apply for a separate decision on the result of the assessment.

****Procedure for late repatriates****

As a late repatriate, you can go through the recognition procedure either in accordance with the laws mentioned here or in accordance with the Federal Expellees Act. You can decide for yourself. The responsible office will advise you which procedure is right for you.

- Apply for recognition as a nurse with a professional qualification from a third country.
 - You need a state permit to work as a nurse in Germany.
 - With this permit, you can officially call yourself a "Pflegefachfrau" or "Pflegefachmann" and work in the profession. You can also apply for the professional title "Pflegefachperson".
 - You can also obtain a state permit in Germany with a professional qualification from a so-called third country. Third countries are all countries that do not belong to the European Union (EU), the European Economic Area (EEA) or Switzerland.
