As a prospective member, you are not a member of the Chamber of Architects. However, you are entitled to use the services of the Chamber of Architects and to participate in the work of the Chamber.
Erforderliche Unterlagen	As a rule, you will need the following documents in particular: • Proof of residence or place of university study in Thuringia. • Proof of identity • Proof of citizenship • Proof of having passed the Bachelor's preliminary examination or an equivalent examination

	As a rule, copies of all documents and certificates must be submitted. As a rule, translations of all documents and certificates in German, prepared by a publicly appointed or sworn interpreter or translator, must be submitted.

Kosten	15 EUR for the procedure before the Registration Committee
Verfahrensablauf	You must apply in writing for entry in the list of interested parties.
