Volltext	<p>According to the definition of Section 14 (1) of the Thuringian Chamber of Architects and Engineers Act of 14.12.2016 (ThürAIKG), non-resident service providers are natural persons who do not have their main residence, a professional branch or the place of their predominant professional activity in the Federal Republic of Germany and who move to Thuringia only for the temporary and occasional provision of services, such as those relating to the exercise of professional tasks of engineers and consulting engineers. The temporary and occasional character of the provision of legally protected services in connection with the exercise of professional tasks of a consulting engineer, engineer authorized to submit building documents, including the use of the protected professional titles "engineer" and "consulting engineer" is decisive.</p>

## Sachverhalt

As far as the foreign person proves the existence of the prerequisites specified in § 14 ThürAIKG or, in case of the authorization to submit building documents, in § 64 of the Thuringian Building Code, this opens the possibility for the foreign person to exercise the aforementioned services across borders in the Free State of Thuringia.

The Chamber of Engineers of Thuringia is the competent body for the Free State of Thuringia to verify the legality of the provision of services under the use of a protected professional title by foreign service providers and, if the legal requirements are met, to make the corresponding entry in the register of foreigners.

It should be noted that the external service provider must notify the Thuringian Chamber of Engineers in writing, enclosing the relevant evidence, even before the first provision of the aforementioned services, including the intended use of the legally protected professional title "Engineer", "Consulting Engineer".

A notification is only not required if the foreign service provider already has a valid certificate of a chamber of architects or engineers of another country corresponding to his field of expertise and informs the Chamber of Engineers accordingly.

In addition to the aforementioned notification, the external service provider must submit an application to the Thuringian Chamber of Engineers for the corresponding entry in the list of external service providers of the Thuringian Chamber of Engineers.

If the foreign service provider applies for the authorization to use the protected professional title "engineer", "consulting engineer" or the authorization to submit building documents, the Thuringian Chamber of Engineers will issue a certificate to the foreign person, provided that the requirements are met. This certificate is limited to one year in the case of an authorization to use the protected professional title "Engineer" or "Consulting Engineer" and, upon application, this period is to be extended by a further

	<p>year in each case.</p> <p>The registration in the list of foreigners kept by the Chamber of Engineers of Thuringia does not imply membership.</p>
<b>Erforderliche Unterlagen</b>	<p>Together with the notification of the first activity in the sense of only temporary or occasional provision of services of professional tasks of an "engineer" or "consulting engineer" according to § 1 ThürIAIKG, the following documents must be submitted:</p> <ul style="list-style-type: none"> <li>• Identity card, passport or passport in copy,</li> <li>• certificate of registration concerning main residence abroad,</li> <li>• NaProof of professional qualification in copy (such as training certificates in original language, if necessary their translation into German by a publicly appointed or sworn interpreter or translator),</li> <li>• Proof of the existence of appropriate professional liability insurance in case of intended self-employment,</li> <li>• if applicable, proof of an already existing notification or comparable entry in the foreigners' register of another federal state,</li> <li>• if applicable, proof of the existence of a comparable authorization to submit building documents in the case of foreign persons who are established in a member state of the EU or an equivalent state as authorized to submit building documents and who are subject to comparable requirements in accordance with Section 64 (3), Sentence 1 ThürBO.</li> </ul>
<b>Voraussetzungen</b>	<p>A notification or application requires that the foreign person intends a temporary or occasional provision of services in the sense of the exercise of professional duties of an "engineer", "consulting engineer" or the authorization to submit building documents and has neither his main residence, professional establishment, nor the place of his predominant professional activity in the Federal Republic of Germany.</p>
<b>Kosten</b>	<p>A fee of €150.00 is charged for the issuance of a certificate of registration in the register of foreign service providers.</p>

## Sachverhalt

Further costs are incurred for the procedure before the registration committee in the amount of € 250.00.

The legal basis for charging fees is the cost regulations of the Thuringian Chamber of Engineers dated 26.10.2017, in accordance with the specifications under § 2 para. 1 g) and para. 2 b).

## Verfahrensablauf

### Bearbeitungsdauer

After presentation of the notification or application, the Thuringian Chamber of Engineers confirms to the foreign person, within one month, the receipt of the notification or application including the submitted evidence and informs, if necessary, which evidence is still missing. After the complete documentation has been submitted, an examination and decision will be made within three months at the latest and, if the requirements for entry in the register of non-residents are met, a certificate will be issued to the non-resident. The registration committee of the Thuringian Chamber of Engineers is responsible for decisions on registration in the list of foreigners kept by the Thuringian Chamber of Engineers in accordance with Section 26 (2) of the ThürAIKG. The documents submitted by the foreign person with the notification or application remain with the Thuringian Chamber of Engineers and are archived there.

### Frist

There are no deadlines to be observed with regard to the point in time of a notification and application for entry in the register of non-residents; rather, the interest of the non-resident is decisive. However, it should be noted that prior to the first activity of a temporary or occasional provision of services of an "engineer" or "consulting engineer" within the meaning of § 1 ThürAIKG, a notification to the Thuringian Chamber of Engineers is required and an authorization to use the protected professional titles "engineer" or "consulting engineer" only exists if the foreign person has been granted a corresponding certificate, which has caused an entry in the register of foreigners at the Thuringian Chamber of Engineers.

An action against a decision of the Chamber of Engineers of Thuringia can be filed within one month after its receipt with the administrative court responsible for the place of residence of the applicant person in writing or for recording by the clerk of the administrative court.

Preliminary proceedings or opposition proceedings do not take place.
