Voraussetzungen	<p>You can apply for prevention measures if the following requirements are met:</p> <ul style="list-style-type: none"> • if you keep your animals on a pasture in Thuringia within the grazing season • if they are sheep, goats, farmed game and other farmed animal species (with a maximum height at withers of 112 cm when fully grown) • if notifiable animals have been reported to the state's animal disease fund or according to the livestock traffic regulations • if the preventive measure (value of the material) and the value of the protected property are in a reasonable ratio <p>Note: You may only start with the implementation of the measure (e.g. purchase of the material) after receipt of the approval notice.</p>

Verfahrensablauf	After a positive review of your application, you will receive a grant notification. You can then purchase the prevention measures. The payment procedure and the form of the proof of use will be regulated in the notice of grant.
