Teaser	As a transport or infrastructure company, would you like to apply for funding for public transport investments? To do so, your project must be included in a funding program of the Free State of Thuringia and the funding must be approved.
Volltext	The approval of funding for operational investments in local public transport (ÖPNV) includes, in particular, projects for the expansion of streetcar and rail infrastructure, the procurement of buses and streetcar vehicles as well as telematics equipment such as operations control systems and passenger information systems. After receiving your application, the authority will check whether the project you have applied for is eligible for funding and can be included in the funding program. As a result, you will receive a notification from the authority as to whether or not it will be included in the funding program. If you are considered, you will be asked to submit an application with all the necessary documents. Once all the application documents have been submitted, the authority will issue a grant notification. You can then commission the implementation of the project. You can apply for payment of the funding as soon as you have received invoices or invoices are expected soon. After completion of the project, you must provide evidence of the use of the funding to the authorities.

- Funding recipient informs authority about award of contract
- An increase in the grant can be applied for depending on the result of the tender and the further cost development during the realization of the project (e.g. supplements)
- Examination of the change requests by the authority and, if necessary, issuance of change notices
- Submission of the call-off application(s) by the grant recipient
- Review of the call-off application by the authority and payment of the grant
- Submission of the proof of use after completion of the project
- Review of the proof of use by the authority
