Volltext	You report damage to a public road. The background procedure is as follows: Clarification of the responsibility of the construction authority, followed by an initial on-site inspection and inspection by the roadway inspection staff. The damage is recorded and the estimated costs for repair are determined. After coordination with the superiors, the removal takes place. or the commissioning of the work to third parties. The road construction administration supervises and accepts the service.

Voraussetzungen	The construction obligation for the road concerned must lie with the Free State of Thuringia or with the districts or independent cities.

Verfahrensablauf	You report damage to a state or county road, or to a sidewalk or bike path that accompanies the state or county road. The background procedure is as follows: Clarification of the responsibility of the construction authority, followed by an initial on-site inspection and inspection by the roadway inspection staff. The damage is recorded and the estimated costs for repair are determined. After coordination with the superiors, the damage is repaired or the service is commissioned to a third party. The road construction administration monitors and accepts the service. Multi-stage procedure: Notification, damage assessment, repair by third parties, inspection and acceptance.
