Teaser	You would like to hold an event at your airfield where aircraft are displayed in flight or compete against each other in a competition? Then you need a permit which you must apply for at the responsible office.
Volltext	Aviation events are associated with special dangers due to the increased traffic density and a large number of visitors. They must therefore be meticulously planned, meticulously executed and closely monitored. They place special demands on the reliability of the organizer and the participating airmen. No aviation event may take place without our permission. We check whether the program and the participants offer the guarantee that the event will be held safely and, in the case of an event permit, we regulate the necessary safety and noise protection measures. During the event, we monitor compliance with these requirements.
