Teaser	Exceptions to the truck driving ban during the vacation travel season (July and August) are possible upon request.
Volltext	For urgent reasons, it may sometimes be necessary to deviate from prescribed driving bans in the Road Traffic Regulations. For such justified individual cases, an exception can be granted after application.
Begriffe im Kontext	
Bearbeitungsdauer	Depending on the individual case and involvement of other agencies.
Fristen	As a rule, no deadlines apply, but an application should be submitted as early as possible and not at short notice. Certain processing times should be granted to the authority.
Formulare + Formular	<p><b>Objekt</b> Forms (also online) are usually provided by the relevant authorities for applications. ## Hinweise (Besonderheiten)

As transport can also be carried out outside the prohibited routes during the vacation travel period (July and August), a particularly strict standard must be applied when considering the granting of exemptions.

The granting of exemptions for commercial purposes must be limited to urgent cases. Detours must be accepted as a matter of principle, since economic or competitive reasons alone do not justify the granting of an exception.

<b>Rechtsbehelf</b>	The decision (administrative act) on an application may be appealed by means of an objection/complaint.
