Teaser	If you want to set up a prostitution vehicle, then you must notify the competent authority.
Volltext	<p>If you intend to set up a prostitution vehicle for operation on more than two consecutive days or several times in a month, you must notify the competent authority.</p> <p>Prostitution vehicles are motor vehicles, vehicle trailers and other mobile equipment provided for the provision of sexual services.</p>
Erforderliche Unterlagen	<p>You must attach the following documents or evidence to the notification:</p> <ul style="list-style-type: none"> • the first and last name of the owner of the vehicle and the full name of the operator of the prostitution vehicle, • a copy of the permit to provide the prostitution

	<p>vehicle,</p> <ul style="list-style-type: none"> • the motor vehicle or vessel registration number of the prostitution vehicle, • the exact indication of the place of installation, • the duration of the installation, • the hours of operation, • Copies of the registration certificates or alias certificates of the prostitutes operating in the prostitution vehicle; and • Copies of the agreements entered into with the prostitutes.
Voraussetzungen	<ul style="list-style-type: none"> • You must be in possession of a valid permit to operate a prostitution business. • You must have the required reliability. • Regulations for the protection of all parties involved with regard to the place of operation, hours of operation and the legal requirements for the corresponding vehicle must be observed.
Kosten	<p>Cost range: Administrative fee EUR 50 - 500 Euro if necessary delivery expenses</p>
Verfahrensablauf	<p>The issuance of a permit requires an application:</p> <ul style="list-style-type: none"> • Application to the competent authority using the prescribed forms and enclosing the required documents. • The submitted documents are checked for completeness and conclusiveness. • If necessary, additional documents will be requested. • If necessary, a site visit is arranged. • A personal meeting is regularly arranged. • If all requirements are met, the permit is issued. The applicant receives a notice of approval. <p>Otherwise, a notice of refusal is issued.</p>

Kurztext	<ul style="list-style-type: none"> • The installation of a prostitution vehicle must be reported to the competent authority. • Certain requirements must be met. • Administrative costs are incurred. • Contact the district office or city council in whose jurisdiction the prostitution vehicle is to be set up for operation.
