Teaser	You can apply for an extension of your residence permit due to a ban on deportation.

Volltext	Your residence permit was issued for at least one year. It can be extended if the ban on deportation and the other conditions for issuance are met. You must urgently ensure that you submit an application for the extension or issuance of another residence title (for example, a settlement permit) before the expiry of your residence title. If the application is filed in time, i.e. before the expiration of the time limit, the further stay is considered permitted until the decision of the Aliens Department with all subsequent effects (for example, the right to pursue gainful employment). A late application (after the end of the time limit stated in the residence title) can result in considerable legal disadvantages.
Erforderliche Unterlagen	• Application for renewal • current biometric passport photo • previous residence permit Further documents depend on the circumstances and can be requested from your contact person.
Voraussetzungen	• The residence permit is extended if the requirements that must be met when it was first issued continue to be met. • An application for extension must be submitted. • There must be no grounds for refusal. • There is no revocation of the determination of the prohibition of deportation by the Federal Office.

Verfahrensablauf	As a rule, you must apply for the extension of your residence title in person at the aliens' registration office responsible for your place of residence. Arrange an appointment with the aliens' registration office responsible for your area. You can also find

information about the application process and which documents you need to submit in which form on the respective website of the foreigners authority.

If your application is approved, the Aliens' Registration Office will commission the Federal Printing Office to produce the electronic residence permit (eAT) in the form of a check card with a new validity date.

For information on the duration of the procedure until the residence title is issued, please contact the relevant Aliens' Registration Office.

Bearbeitungsdauer

You will usually be informed of the duration of the procedure (about 6 to 8 weeks) when you apply for an extension by the competent foreigners authority. Note: The residence permit is issued as an electronic residence title.

Frist

Apply for the extension of your residence permit at your competent aliens' registration office in due time before the expiry of the validity. Inquire about this at your responsible foreigners authority. Period of action: 1 month

Settlement permit can be issued after five years upon application and if the requirements are met.

Rechtsbehelf

An appeal against the decision of the Foreigners' Registration Office may be filed with the court specified in the decision.

- For the extension of the residence permit, the same conditions must be met as when it was issued.
- Prohibition of deportation must still be present
- There must be no grounds for refusal.
