Kurztext	• Information from the Civil Register in Special Cases - Issuance to Housing Providers • The owner of a dwelling may request information from the civil register about the persons living in the dwelling. • Legal interest must be substantiated • The same right has housing provider, if the owner of the dwelling is not himself housing provider. • Responsible: The registration office in whose area of responsibility the dwelling is located.
