Erforderliche Unterlagen	- Valid passport or passport replacement
Voraussetzungen	- You have a recognized and valid passport or passport replacement and - if required for entry - an appropriate visa.
Kosten	Gebühr: 100€ Under certain circumstances, a fee reduction or fee waiver may be considered.
Verfahrensablauf	The residence permit must be applied for at the foreigners authority responsible for your place of residence. The procedure is as follows:
