Teaser	You must extend your residence permit, which was issued to you for education and training purposes, in good time if you wish to continue your education or training in Germany.
Volltext	<p>If you have a residence permit for the purpose of education and training whose validity is about to expire, you must apply for the extension of the residence permit in due time.</p> <p>The same requirements must be met for the extension of the residence permit as for the initial issuance. In principle, your residence permit can be extended until the end of the training or further education if the training or further education relationship continues and is expected to be completed successfully.</p> <p>For the entire duration of the in-company training or further training, you must provide proof that you are</p>

able to support yourself.

The residence permit can only be extended if the approval of the Federal Employment Agency remains valid. The Foreigners Authority checks this in an internal procedure and obtains the approval again if necessary.

An extension is excluded if this was already ruled out by the Foreigners' Registration Office when the residence permit was issued or when it was last extended.

The residence permit is limited in time. As a rule, its validity depends on the remaining duration of the education or training.

If you were obliged to take part in an integration course when the residence permit was issued, you must prove that you have fulfilled this obligation. If you have not yet completed the integration course, the Aliens' Registration Office can refuse to extend your residence permit or can only extend it for one year until you have successfully completed the course or until proof has been provided that you have been integrated into social life in some other way.

If you have not yet reached the age of 18, a person entitled to your personal care must agree to the extended stay for the purpose of continuing the vocational training or further education.

During the qualified vocational training, you are permitted to pursue employment. However, the extension of your residence permit is only possible if the successful completion of your vocational training is not jeopardized by the pursuit of gainful employment.

After successful completion of qualified vocational training, your residence permit may be extended for up to twelve months for the purpose of finding a job.

Should your qualified vocational training or further training end prematurely for reasons beyond your control, you may be granted the opportunity to look

for another training place for a period of up to six months.

During the validity of a residence permit for in-company vocational training and continuing education, it is generally possible to change to another qualified vocational training program. Likewise, if you meet the necessary requirements, you can apply to the Aliens' Registration Office to obtain a residence permit for employment as a skilled worker, for employment with distinctive practical vocational knowledge, for study or for other purposes to which you are legally entitled (change of purpose).

Erforderliche Unterlagen

- Valid passport or passport replacement
- Current residence permit
- Current biometric photo
- Education or training contract
- Proof that your livelihood continues to be secured (including rental contract)
- Proof of health insurance
- Consent from the Federal Employment Agency (if this has already expired)
- Consent of the person with parental authority to the extended stay, if you have not yet reached the age of 18.
- If applicable, proof that the integration course has been completed or that integration into social life has otherwise taken place.

Voraussetzungen

- You possess a recognized and valid passport or passport replacement.
- There is no interest in deportation against you.
- Your stay does not endanger or impair the interests of the Federal Republic of Germany.
- Your livelihood is secured.
- The approval of the Federal Employment Agency has been obtained.

Kosten

Extension of residence permit:

- for a further stay of up to three months: EUR 96,00
- for a further stay of more than three months: EUR 93.00 Under certain conditions, a fee reduction or fee exemption may be considered.

Note: The fee for reissuing the electronic residence permit (eAT card) is EUR 67.00.

Verfahrensablauf

You must apply for the extension of your residence permit at the aliens' registration office responsible for your place of residence before your current residence title expires.

The procedure is as follows:

- Depending on the foreigners authority and your concerns, it may be possible to apply via the Internet. Find out whether your foreigners authority offers electronic application. In the case of an electronic application, the Aliens' Registration Office will contact you after receiving your application to arrange an appointment at the Aliens' Registration Office. During the appointment, your supporting documents will be reviewed (bring the originals with you to the appointment).
- If the application can only be submitted in person, make an appointment with the Aliens' Registration Office. During the appointment, your application will be received and your supporting documents will be checked (bring the originals to the appointment).
- If the approval of the Federal Employment Agency has to be renewed, the Foreigners' Registration Office will usually obtain it in an internal administrative procedure.
- Your residence permit will then either be extended or you will receive a rejection notice.
- For the renewal of the residence permit, your current electronic residence title (eAT card) will be renewed. For the renewal, your fingerprints will be taken at the Aliens' Registration Office. You will also have to provide a signature.
- After about six to eight weeks, you can pick up your eAT card at the Aliens' Registration Office. As a rule, you must pick it up in person.
- There are fees for the extension of the residence permit. The timing and form of payment vary depending on the authority.
- The extension of the residence permit is limited in time and is only valid for this purpose of stay.

	<ul style="list-style-type: none"> • If the purpose of your stay changes, you must inform the relevant immigration authority immediately. <p>You must apply for the extension of the residence permit in good time before the period of validity expires.</p>
Bearbeitungsdauer	Duration (at span): about 6 to 8 weeks Note for further information on processing time: The processing time may vary depending on the workload of the Foreigners' Registration Office. It takes about 4 to 6 weeks for the Bundesdruckerei to produce the electronic residence permit.

Kurztext	<ul style="list-style-type: none"> • Residence permit for the purpose of training Extension for the purpose of training and further education • Residence permit can be extended in order to continue the in-company vocational training or further training begun in Germany. • The same requirements must be met for the extension as for the initial granting of the permit, e.g. proof of subsistence must continue to be provided for the entire duration of the in-company vocational training or further training. • Gainful employment is permitted for up to ten hours per week during the qualified vocational training; otherwise not permitted; self-employment is not permitted under any circumstances. • The approval of the Federal Employment Agency must be continued or renewed.

- The extension of the residence permit for the purpose of education and further training is limited in time; validity usually depends on the remaining duration of the education or further training.
- In the case of persons who have not yet reached the age of 18, the consent of a person with parental authority is required for the extension of the residence.
- If the obligation to participate in an integration course was stated when the residence permit was issued, proof must be provided that the obligation has been fulfilled. If the integration course has not yet been completed, the Aliens' Registration Office can refuse to extend the residence permit or can only extend it for one year until the course has been successfully completed or proof has been provided that integration into social life has taken place in another way.
- The residence permit is only valid for the purpose of education or training; a change to another qualified vocational training is possible; a change of the purpose of residence (e.g. study) is only possible under certain conditions.
- After completion of the qualified vocational training, a residence permit for the purpose of looking for a job can be issued for twelve months.
- In case of premature end of the qualified vocational training, there is the possibility to search for a training place for up to six months.
- An extension is excluded if this was already excluded when the permit was issued or last extended.
- The application must usually be made in person, but may also be possible via the Internet.
- The extension of the residence permit is subject to a fee; the time and form of payment vary.
- Responsible: the foreigners authority responsible for the applicant's place of residence.
