Teaser	Has your total income increased, your rent burden or the number of household members decreased? Then you must notify the housing benefit authority of these changes.
Volltext	In certain cases, you must notify the relevant housing benefit authority of any changes to your current housing benefit entitlement. The changes can lead to a reduction or, if necessary, to
	the complete discontinuation of housing benefit.
Erforderliche Unterlagen	In addition to the form to be completed (notification of change), you must also submit further documents as proof of the changes that have occurred. Further documents may include in particular • Proof of income (salary certificate, pension statement, etc.),
	Rental agreement or documents on the encumbrance of the residential property you use, if you are its owner.
	Please refer to the application form or the information provided by your local housing benefit office to find out which documents you need to submit in your specific case
Voraussetzungen	Notify the relevant housing benefit authority immediately if, during the current grant period and not just temporarily, i.e. for longer than four months
	 your rent/burden - excluding heating costs - is reduced by more than 15 percent, the income of household members increases by

	 more than 15 percent, the number of household members is reduced, one or more household members apply for or receive transfer benefits (citizen's allowance, social benefit, basic income support), a single household member has died (notification by the heirs or guardians).
Kosten	There are no fees.
Verfahrensablauf	The competent housing benefit authority will decide ex officio on the payment of housing benefit if there have been more than temporary changes in your circumstances during the current grant period. Please inform the competent housing benefit authority immediately if there are any changes that are not only temporary during the current approval period. Once you have reported the changes, you will receive a notification from your housing benefit authority if the amount of housing benefit has changed.

Frist	You must notify the responsible office of any changes immediately.

Hinweise	In order to avoid or uncover unlawful claims for housing benefit, the housing benefit authority may regularly check the household members by means of a so-called data comparison (for example with the registration authorities or the German Pension Insurance). Rechtsbehelf	After you have notified the changes, you will receive a notification from your housing benefit authority if the amount of housing benefit has changed. If you feel that your rights have been infringed by this decision, you can lodge an appeal against it. If you intend to lodge an appeal against the decision of the housing benefit authority, you must do so within one month of receiving the decision. The same applies if you wish to appeal against the decision. You will find all the necessary information in the information on legal remedies at the end of the notice.
Kurztext	 Change in housing benefit In the following cases, you must notify us of any changes to your current housing benefit entitlement: if the rent/charge (excluding heating costs) is reduced by more than 15 percent, if the income of the household members increases by more than 15 percent, if the number of household members decreases, if one or more household members apply for or receive transfer benefits (citizen's allowance, social benefit, basic income support), in the event of the death of a single household member (notification by the heirs or guardians). The changes can lead to a reduction or, if applicable, to a complete discontinuation of the housing benefit. The following documents must be enclosed with the application: Proof of the changes that have occurred (e.g. regarding the changed income or the changed rent or charges). The housing benefit authorities are responsible.
