Volltext	<p>As a beneficiary of social welfare or basic income support, you will be supported by the social welfare office during pregnancy and maternity - if you do not have health insurance. You will receive the normal health insurance benefits:</p> <ul style="list-style-type: none"> <li>• Medical treatment and care,</li> <li>• Support from midwives,</li> <li>• medicines, bandages and remedies.</li> </ul> <p>If needed, you will receive care in inpatient facilities. If you need care at home and your family cannot provide it, home care costs are also covered on a pro-rata basis. However, this depends on the care level.</p>

Voraussetzungen	Health assistance is provided to persons who do not have statutory health insurance or do not have sufficient private health insurance, for whom the provision of services through the health insurance fund (Section 264 (4) of the German Social Code, Book V) is not an option, and who cannot reasonably be expected to raise the funds for the necessary assistance from their income and assets.
