Teaser	Tolerated foreigners can obtain a residence permit for employment if they meet certain requirements.
Volltext	As a tolerated foreign person, you can obtain a residence permit to pursue employment if you have completed qualified vocational training or university studies in Germany. Qualified vocational training exists if you have completed vocational training in a state-recognized or comparably regulated training occupation. The duration of the training must have been at least two years. If you have obtained your university degree abroad, you can obtain a residence permit if your foreign degree has been legally recognized in Germany or is comparable to a German university degree. The Central Office for Foreign Education is responsible for the recognition of foreign university degrees in Germany (see "Further Information"). In addition, it is required that you have been employed with your foreign university degree for two years without interruption in an occupation appropriate to the degree. The employment is appropriate if it usually requires an academic degree and the knowledge acquired with the university education is at least partially or indirectly required. Shorter interruptions of employment, which as a rule should not exceed a total

duration of three months, are harmless.

You can also obtain a residence permit if you have acquired your professional qualification abroad, have been in qualified employment for three years without interruption and have not been dependent on public funds (with the exception of benefits to cover the necessary costs for accommodation and heating) for your livelihood and that of your family members or other household members within the last year before applying for the residence permit. Qualified employment exists if it is usually performed by persons with skills, knowledge and abilities acquired in qualified vocational training or academic education. Shorter interruptions (up to three months) are usually harmless,

The residence permit is issued for a limited period for the duration of the employment. For the holders of the training toleration, the residence permit is issued for two years if they want to pursue an occupation that corresponds to the qualification acquired in the vocational training.

Erforderliche Unterlagen

- Valid passport or passport replacement
- Current biometric photo
- Proof of completed education (e.g. university degree, certificates of completed vocational training)
- In the case of foreign university degrees: notice of recognition or comparability of the university degree, certificate evaluation from the Central Office for Foreign Education (ZAB), if available
- Employment contract or the declaration of employment completed and signed by the employer (see under "Further information")
- If applicable, proof of previous employment (e.g. references, employment contracts)
- Proof of German language skills
- Evidence of livelihood security (e.g. equity capital, blocked account, declaration of commitment)
- Proof of health insurance
- Current Certificate of registration In individual cases, the Aliens Department may request further documents.

Voraussetzungen

 You possess a recognized and valid passport or passport replacement.

	 There is no interest in deportation against you. Your stay does not endanger or impair the interests of the Federal Republic of Germany. completed qualified vocational training in a state-recognized or comparably regulated training occupation or a university degree, or with a recognized foreign university degree or a foreign university degree comparable to a German one have been continuously employed for at least two years in an occupation appropriate to their degree, or have been in qualified employment without interruption for at least three years and have You have in the Federal Republic of Germany They have sufficient German language skills (B1). You can present a concrete job offer or a contract. The "Declaration of employment relationship" serves as proof of the concrete job offer. You have sufficient living space for yourself and your family. The Federal Employment Agency has approved your employment. You are able to secure your livelihood and health insurance coverage from your own resources without drawing on public benefits.
Kosten	Gebühr: 100€ Under certain circumstances, a fee reduction or fee waiver may be considered. Notes: - Additional fees may apply for the issuance of the residence permit in the form of the electronic residence title, which can also be used as electronic proof of identity The time and the form of the fee collection as well as the payment vary depending on the authority.
Verfahrensablauf	The procedure is as follows:

Kurztext	 Residence permit for the purpose of gainful employment, issued to qualified tolerated persons for the purpose of employment have completed qualified vocational training in a state-recognized or comparably regulated training occupation or a university degree, or with a recognized university degree or a foreign university degree comparable to a German university degree, have been continuously employed for two years in an occupation appropriate to their degree, or have been in qualified employment without interruption for three years and have not been dependent on public funds within the last year, with the exception of benefits to cover the necessary costs for accommodation and heating Tolerated foreigners who in Germany may be granted a residence permit for the purpose of employment. The foreign person must have at least sufficient knowledge of the German language (B1). The foreign person must prove sufficient living space. The Federal Employment Agency must agree to the pursuit of employment. The residence permit is issued for a limited period for the duration of the employment. For holders of the training toleration, the residence permit is to be issued for two years. Depending on the foreigners authority and the request, the application is possible via the Internet or in person. A fee is charged for the issuance of the residence
