Teaser	You want to give up your existing permit wastewater into a surface water and / or via infiltration into groundwater? Then an application for revocation must be submitted to the competent authority for this purpose.
Volltext	A permit for the discharge of wastewater (precipitation water, sewage, combined sewage) into a surface water body and / or via infiltration into groundwater can be revoked in Germany. For this purpose, an application can be submitted to the competent authority.
Erforderliche Unterlagen	The required documentation (essentially justification) is dependent on the wastewater discharge permit being revoked.
Voraussetzungen	The water use permitted by the permit will not be exercised in the future.
Kosten	An administrative fee must be paid to the respective federal state for the administrative service "Discharge of wastewater into bodies of water Revocation of permit". The administrative fee is based on the respective state's regulations on administrative fees.
Verfahrensablauf	
Bearbeitungsdauer	The processing time depends on the quality and volume of the applications and documents submitted.
Frist	There are no deadlines to be observed.
