| Volltext                      | <p>For the entire period of benefit receipt, you must notify the maintenance advance office of any important changes.</p> <p>You must notify all changes that may be important for the claim or about which you have made declarations in connection with the advance maintenance payment.</p> <p>You must indicate the changes after 14 days at the latest.</p> <p>Examples of changes:</p> <ul style="list-style-type: none"> <li>• Your child no longer lives with you</li> <li>• You are moving.</li> <li>• You are getting married.</li> <li>• You move in with the other parent.</li> <li>• The other parent pays child support again or wants to pay child support again.</li> <li>• You become aware of the previously unknown whereabouts of the other parent.</li> </ul> |
