Bearbeitungsdauer	According to the Federal Ministry of the Interior, for Construction and Homeland, it usually takes at least two weeks from the time of application until you can pick up your ID card at the Citizens' Registration Office. In some cases, however, it can take several weeks. Please contact your local ID card office for information on the current average production time.
