Teaser	You were born in Germany as a child of stateless parents? Then you are entitled to naturalization under certain conditions.
Volltext	<p>With naturalization you receive German citizenship. This means that you become an equal citizen of the Federal Republic of Germany with all rights and obligations.</p> <p>Among other things, you can</p> <ul style="list-style-type: none"> • exercise your right to vote in the federal states and for the German Bundestag, • enjoy freedom of movement within the European Union as a citizen of the Union, and • can also travel outside Europe to many countries without a visa. <p>If you have been stateless since birth in Germany, you are entitled to acquire German citizenship through naturalization under certain conditions.</p> <p>Stateless persons are persons whom no state regards as nationals on the basis of its law.</p> <p>For this you must</p> <ul style="list-style-type: none"> • have been born in the Federal Republic of Germany as a stateless person, • have resided legally and permanently in Germany for at least 5 years, and • have filed the application before reaching the age of

	<p>21.</p> <p>The claim is excluded if you have been legally sentenced to a custodial or juvenile sentence of more than 5 years.</p> <p>If you are being investigated on suspicion of a criminal offense, the naturalization procedure remains suspended until the conclusion of the proceedings.</p> <p>Naturalization becomes effective upon delivery of the naturalization certificate. The competent authority is the citizenship authority responsible for your place of residence (administrative district or independent city).</p>

Voraussetzungen	<ul style="list-style-type: none"> • You must apply for naturalization before your 21st birthday. • You must be at least 16 years old or be legally represented. • You have been stateless since birth. • You were born in Germany. • You have been legally and permanently residing in Germany for at least 5 years. • You have not been sentenced to a custodial or juvenile sentence of more than 5 years. • You are not being investigated on suspicion of a criminal offense. If you are, the naturalization procedure remains suspended until the criminal proceedings have been concluded.

Kurztext	<ul style="list-style-type: none"> • Naturalization: granting of German citizenship to stateless persons since birth. • stateless persons are persons whom no state regards as nationals on the basis of its law • those who have been stateless since birth in Germany are entitled to naturalization under certain conditions • They must have resided legally and permanently in Germany for at least 5 years and apply for naturalization before their 21st birthday • with the naturalization you receive German citizenship and are an equal citizen of the Federal Republic of Germany with all rights and obligations. • Your naturalization becomes effective with the delivery of the naturalization certificate. • responsible: Citizenship authority of the respective place of residence
