the economy in Germany and

- the financing of the implementation is secured by equity capital or by a loan commitment.

If you have already reached the age of 45, an appropriate retirement provision is also required.

Furthermore, the general conditions for granting a residence permit must be fulfilled.

These are in particular:

- a secure livelihood,
- a clarified identity,
- possession of a valid passport or passport replacement.

Kosten

Gebühr: 100€

Under certain circumstances, a fee reduction or fee waiver may be considered.

Notes: - Additional fees may apply for the issuance of the residence permit in the form of the electronic residence title, which can also be used as electronic proof of identity. - The time and the form of the fee collection as well as the payment vary depending on the authority.

Verfahrensablauf

Depending on the foreigners authority and your request, it may be possible to apply via the Internet. Find out whether your foreigners authority offers electronic application for the residence permit.

If the application is only possible in person

- Make an appointment with the Foreigners' Registration Office
- During the appointment, your application will be accepted and your documents will be checked (bring them with you to the appointment).
- For the production of an electronic residence permit (eAT card) your fingerprints will be taken.

In the case of an electronic application:

- the Aliens' Registration Office will contact you after receiving your online application to arrange an appointment at the Aliens' Registration Office, if necessary.
- During the appointment, your supporting documents will be checked (bring them with you to the appointment) and your fingerprints will be taken for the production of the eAT card.

If your application is approved, the Aliens' Registration Office will arrange for the eAT card to be produced.

After about six to eight weeks, you can pick up the eAT card at the Aliens' Registration Office.

The eAT card must always be collected in person.

Frist

The residence permit should be applied for at least eight weeks before the expiry of your still valid visa or your current residence permit or - if you are staying in Germany legally without a visa - within 90 days after entry. The residence permit is issued for a maximum of 3 years. Action period: 1 month

An appeal against the decision of the Foreigners' Registration Office may be filed with the court specified in the decision.
