| Teaser | If you wish to work temporarily as a foreign financial investment intermediary and advisor in Germany, you must notify the competent authority. |
| Volltext | As a financial investment broker and advisor, you need a permit in Germany. If you wish to act as a financial investment intermediary on a self-employed basis only on a temporary basis, prior written notification to the competent authority is sufficient. However, this only applies to EU or EEA citizens. |
| Erforderliche Unterlagen | Proof of citizenship (e.g. by identity card or passport). | Verfahrensablauf | The granting of the permit is automatically entered in the Register of Intermediaries. After you have received the permit, you must register your trade before starting your activity. |
