Teaser	If you move out of a secondary residence and do not move into another domestic residence, you must deregister for that residence.
Volltext	<p>If you move out of one of several apartments (secondary residence) and do not move into another apartment in Germany, you must deregister for this apartment within 2 weeks. This is usually the case if you move abroad permanently or give up your previous apartment without moving into a new apartment in Germany or give up your secondary apartment.</p> <p>De-registration ex officio is possible and occurs if you have not fulfilled your obligation to de-register.</p> <p>If you do not deregister within two weeks, you are acting irregularly. In this case, you can be fined.</p>
Erforderliche Unterlagen	<p>Identification documents of the persons to be deregistered.</p> <p>If you are unable to appear in person, the registration form signed by you can also be presented by an authorized person (power of attorney required). In the case of families, it is sufficient if one of the adult family members appears in person and the family has moved out together. Please remember to bring all IDs and passports of the family members.</p>

	<p>a new dwelling in the country.</p> <p>In the case of temporary absence with the possibility and intention to continue using the apartment, there is no obligation to deregister.</p> <p>In the case of persons under 16 years of age, it is important to note that they must be deregistered by the persons from whose dwelling they are moving out.</p> <p>In contrast to moving in, moving out does not need to be confirmed separately by the housing provider.</p>

Verfahrensablauf	<p>The deregistration process is as follows:</p> <p>In person:</p> <ul style="list-style-type: none"> <li>• You audition at the competent authority and fill out a registration form.</li> <li>• You present the identification documents of the persons to be deregistered.</li> <li>• You will then receive the official registration confirmation from the registration office.</li> </ul> <p>In writing:</p> <ul style="list-style-type: none"> <li>• You notify the registration office of the departure with the completed registration form.</li> <li>• You enclose copies of the identity documents of the persons to be deregistered.</li> <li>• You receive the official registration confirmation from the registration office by mail.</li> </ul> <p>Electronically:</p> <ul style="list-style-type: none"> <li>• If electronic access has been set up by the registration office, you can also deregister electronically.</li> </ul>

Frist	<p>You have to deregister within 2 weeks after moving out of the secondary residence, if you do not move into a new residence in Germany You can already deregister</p>

	in the week before moving out of the residence. In this case, the registration register will only be updated on the date of the actual move-out.

Hinweise	You will receive a confirmation of deregistration free of charge.

Kurztext	<ul style="list-style-type: none"> <li>• Residence Deregistration of secondary residence</li> <li>• Anyone who moves out of a secondary residence and does not move into another residence in Germany must deregister for this residence.</li> <li>• The deregistration must within 2 weeks after moving out of the secondary residence.</li> <li>• responsible: Registration office</li> </ul>
Ansprechpunkt	<p>The secondary residence can be deregistered both at the registration office of the main residence and at the registration office responsible for the secondary residence.</p> <p>In the case of deregistration at the registration office responsible for the secondary residence, the latter must forward the information to the registration office of the main or sole residence.</p>
