You belong to one of the following groups of people:

blind people,

severely disabled persons with bilateral amelia or phocomelia or with comparable functional disorders, whereby the time limitations that require the operation of the parking disc do not apply, or

You belong to one of the following groups of persons:

severely disabled persons with the characteristic signs "G" and "B" and a degree of disability of at least 80 for functional disorders of the lower limbs alone (and the lumbar spine, insofar as these affect the ability to walk);

severely disabled persons with the signs "G" and "B" and a degree of disability of at least 70 for functional disorders of the lower limbs (and the lumbar spine, insofar as these affect the ability to walk) alone and at the same time a degree of disability of at least 50 for functional disorders of the heart or the respiratory organs;

severely disabled persons suffering from Crohn's disease or ulcerative colitis, if they have a degree of disability of at least 60;

severely disabled persons with an artificial bowel outlet and at the same time an artificial urinary diversion, if they have a degree of disability of at least 70.

Notes

The exemptions are valid for the whole of Germany.

The application for the extension of the exemption must be submitted to the locally responsible road traffic authority.

	between authorities and may depend on the type of application (in person or online).
Frist	The extension can only be applied for from a certain point in time before the current parking permit expires. This varies, so you should enquire about this with your responsible road traffic authority. The renewed permanent exemption permit is issued for a maximum of five years. It can be revoked.
