- Prerequisite: Application Economically unable to perform Economic incapacity is always present in the following cases: Benefits according to SGB II (citizen's allowance or benefits according to the education and participation package) Benefits according to §§ 2, 3 of the Asylum Seekers' Benefits Act (Asylbewerberleistungsgesetz) Benefits according to the third and fourth chapters of SGB XII Receipt of child benefit supplement according to § 6a of the Federal Child Benefit Act (Bundeskindergeldgesetz) Receipt of housing allowance according to the Housing Allowance Act
