Teaser	You can extend your residence permit to pursue qualified employment for skilled workers with vocational training before the expiration of its time limit if you want to continue employment in Germany as a skilled worker.
Volltext	<p>The residence permit for qualified employment for skilled workers with vocational training is a temporary residence title. You can apply for the extension of the residence permit for the purpose of qualified employment if your employment is to be continued beyond the period of validity of your residence permit.</p> <p>Apply for the extension of your residence permit at the foreigners authority responsible for your place of residence at least eight weeks before the expiry of the time limit.</p> <p>For the extension of the residence permit for the</p>

purpose of qualified employment for skilled workers with vocational training, the same requirements apply as for the granting. In particular, you should be able to present a concrete job offer or an employment contract and pursue employment that is professionally related to your qualification.

If you were required to attend an integration course when your residence permit was first issued, this will be taken into account when your residence permit is extended. If you have not yet taken part in an integration course, the Foreigners' Registration Office may reject your application for an extension of your residence permit. If you have not yet completed the integration course, your residence permit will generally only be extended for one year at a time until you successfully complete the course or provide proof that you have been integrated into social life in some other way.

In the case of an extension, your residence permit will be limited again. The residence permit for qualified employment for skilled workers with vocational training is extended for the duration of the employment contract.

As a rule, the residence permit cannot be extended if this was already ruled out when the residence permit was issued or last extended.

- Proof of income for the last 3 months
- In case of change of employer: concrete job offer (please use the nationwide standardized form Declaration of Employment Relationship)
- Current biometric photo
- Current certificate of registration
- Rental contract
- Proof of health insurance
- If you are required to take part in an integration course: certificate of successful participation in the

integration course or other proof of your integration efforts

Voraussetzungen

- You have a recognized and valid passport or passport replacement as well as the valid residence permit for qualified employment for skilled workers with vocational training according to § 18a AufenthG.
- The period of validity of your residence permit will expire in the near future.
- There is no interest in deportation against you.
- Your stay does not endanger or impair the interests of the Federal Republic of Germany.
- You can secure your livelihood and health insurance coverage from your income without claiming public benefits.
- You have a concrete job offer or an employment contract with the same or another employer.
- You are engaged in employment that is professionally related to your qualifications.
- If required, you have a professional practice permit.
- The Federal Employment Agency has approved your taking up employment (approval is usually obtained from the Foreigners' Registration Office) For approval, your working conditions (in particular salary) must be comparable to those of a German employee in the same position, among other things.

Verfahrensablauf

The extension of your residence permit must be applied for at the aliens' registration office responsible for your place of residence.

- Depending on the foreigners authority and your request, it may be possible to apply via the Internet. Find out whether your foreigners authority offers electronic application for the residence permit.
- If the application is only possible in person, make an appointment with the Aliens' Registration Office.
- During the appointment, your application will be

received and your supporting documents will be reviewed (please bring them to the appointment). Your fingerprints will be taken for the issuance of the electronic residence permit (eAT card).

- In the case of an electronic application, the Aliens' Registration Office will contact you after receiving your online application to make an appointment for an interview at the Aliens' Registration Office. During the appointment, your supporting documents will be checked (please bring them to the appointment) and your fingerprints will be taken for the issuance of the eAT card.
- If your application is granted, the Aliens' Registration Office will arrange for the eAT card to be produced.
- After about six to eight weeks, you can pick up your eAT card at the Aliens' Registration Office.
- There are fees for the extension of the residence permit. The timing and form of payment vary depending on the authority.

Frist

- Extension of the residence permit: at the latest eight weeks before the expiry of your still valid residence permit for the purpose of qualified employment for skilled workers with vocational training.
- Action period: 1 month

An appeal against the decision of the Foreigners' Registration Office may be filed with the court specified in the decision.

Kurztext

- Residence permit extension for the purpose of employment in qualified employment as a specialist with vocational training.
- Residence permit for the purpose of qualified employment as a skilled worker with vocational training may be extended if its period of validity expires in the near future and the employment as a skilled worker is to be continued.
- The extension must be applied for no later than eight

weeks before the expiry of the time limit.

- An extension of the residence permit for skilled workers with vocational training is only possible if the prerequisites that existed when the permit was first issued continue to be met.
- In the course of the extension, the residence permit is limited again.
- If the period of validity of the approval obtained when the residence permit was issued has expired, the approval of the Federal Employment Agency must be obtained again.
- If the obligation to participate in an integration course was stated when the residence permit was issued, proof must be provided that the obligation has been fulfilled. If the integration course has not yet been completed, the Foreigners' Registration Office can refuse to extend the residence permit or can only extend it for one year until the course has been successfully completed or proof has been provided that integration into social life has taken place in another way.
- An extension is excluded if this was already ruled out by the foreigners authority when the permit was issued or the last extension was issued.
- Depending on the foreigners authority and the request, the application is possible via the Internet or only in person.
- There are fees for the extension. The time as well as the form of payment varies depending on the authority.
- Responsible: the foreigners authority responsible for the applicant's place of residence.
