Teaser	You can extend your residence permit for the purpose of research before its expiry date if you wish to continue your activity as a researcher in Germany.
Volltext	The residence permit for the purpose of research is a temporary residence title. You can apply for an extension of the residence permit for the purpose of research if you want to continue your work at a German research institution beyond the period of validity of your residence permit. Apply for the extension of your residence permit at the Foreigners' Registration Office responsible for your place of residence at least eight weeks before the expiry of the time limit. For the extension of the residence permit for the purpose of research, the same requirements apply as for the granting. In particular, you should be able to
	present a hosting agreement or a corresponding contract with a research institution. If you were required to attend an integration course when your residence permit was first issued, this will

be taken into account when your residence permit is extended. If you have not yet attended an integration course, the Foreigners' Registration Office may reject your application for an extension of your residence permit. If you have not yet completed the integration course, your residence permit will generally only be extended for one year at a time until you successfully complete the course or provide proof that you have been integrated into social life in some other way.

In the case of an extension, your residence permit will be limited again. The residence permit for the purpose of research is extended for the duration of the research project.

As a rule, the residence permit cannot be extended if this was already ruled out when the residence permit was issued or last extended.

Erforderliche Unterlagen

- Valid passport or passport replacement
- Existing residence permit
- Current biometric photo
- Hosting agreement or a corresponding contract with a research institution to carry out the research project
- Rental agreement
- Proof of living expenses (including 3 proofs of income for the last 3 months)
- Proof of your health insurance
- If you are required to take part in an integration course: certificate of successful participation in the integration course or other proof of your integration efforts

Voraussetzungen

- You have a recognized and valid passport or passport replacement as well as the valid residence permit for the purpose of research according to § 18d paragraph 1 AufenthG.
- The period of validity of your residence permit will expire in the near future.
- There is no interest in deportation against you.
- Your stay does not endanger or impair the interests of the Federal Republic of Germany.
- You can secure your livelihood and health insurance coverage from your income without recourse to public benefits.

	 You have an admission agreement or corresponding contract to carry out a research project at a research institution. In the case of an obligation to participate in an integration course by the Aliens' Registration Office: You can provide proof of successful participation in the integration course or proof that your integration into social and societal life has taken place in another way.
Kosten	Gebühr: 96€ for a further stay of up to three months Gebühr: 93€ for a further stay of more than three months Under certain circumstances, a fee reduction or fee waiver may be considered.
Verfahrensablauf	The extension of your residence permit must be applied for at the aliens' registration office responsible for your place of residence. • Depending on the foreigners authority and your request, it may be possible to apply via the Internet. Find out whether your foreigners authority offers electronic application for the residence permit. • If the application is only possible in person, make an appointment with the Aliens' Registration Office. • During the appointment, your application will be received and your supporting documents will be reviewed (please bring them to the appointment). Your fingerprints will be taken for the issuance of the electronic residence permit (eAT card). • In the case of an electronic application, the Aliens' Registration Office will contact you after receiving your online application to make an appointment for an interview at the Aliens' Registration Office. During the appointment, your supporting documents will be checked (please bring them to the appointment) and your fingerprints will be taken for the issuance of the eAT card. • If your application is granted, the Aliens' Registration Office will arrange for the eAT card to be produced. • After about six to eight weeks, you can pick up your eAT card at the Aliens' Registration Office.

Rechtsbehelf	An appeal against the decision of the Foreigners' Registration Office may be filed with the court specified in the decision.
Kurztext	 Residence Permit for the Purpose of Gainful Employment Extension for the Purpose of Research Residence permit for the purpose of research can be extended if its period of validity expires in the near future and the activity at the research institution is to be continued. The extension must be applied for at least eight weeks before the expiry of the time limit. An extension of the residence permit for the purpose of research is only possible if the conditions that existed when the permit was first issued continue to be met. In the course of the extension, the residence permit will be limited again. If the obligation to attend an integration course was stated when the residence permit was issued, proof must be provided that the obligation has been fulfilled. If the integration course has not yet been completed, the Foreigners' Registration Office can refuse to extend the residence permit or can only extend it for one year until the course has been successfully completed or proof has been provided that integration into social life has taken place in another way. An extension is excluded if this was already excluded by the foreigners authority when the permit was issued or the last extension was issued. Depending on the foreigners authority and the
