expiry of the time limit.

The same requirements apply for the extension as for the issuance. In particular, you should continue to work in the IT industry and be able to demonstrate a certain salary.

When your residence permit was first issued, the Federal Employment Agency gave its approval. If the validity of the consent has expired, it must be granted again for the extension of your residence permit.

Under certain circumstances, you were required to attend an integration course when your residence permit was first issued. If this is the case, this must be taken into account when extending your residence permit. If you have not yet taken part in an integration course, the Foreigners' Registration Office may reject your application for an extension of your residence permit. If you have not yet completed the integration course, your residence permit will generally only be extended for one year at a time until you successfully complete the course or provide proof that you have been integrated into social life in some other way.

In the case of an extension, your residence permit will be limited again. The duration of the time limit depends on the duration of your employment contract or the period of validity of the approval of the Federal Employment Agency.

As a rule, the residence permit cannot be extended if this was already ruled out when the residence permit was issued or last extended.

- Valid passport or passport replacement
- Current residence permit
- Original of your employment contract or a binding job offer with salary information (please use the federal form for this purpose) Declaration of employment)
- Current biometric photo
- Current certificate of registration
- Proof of your health insurance
- Rental agreement

Voraussetzungen

- You have a recognized and valid passport or passport substitute as well as a valid residence permit for employment with distinct professional practical knowledge.
- The period of validity of your residence permit will expire in the near future.
- There is no deportation interest against you.
- Your stay does not endanger or impair the interests of the Federal Republic of Germany.
- You have a new employment contract or a new binding job offer with the same or another employer in the IT sector.
- Your salary will continue to reach at least 60% of the contribution assessment ceiling in the pension insurance. In 2023, 60% corresponds to a gross minimum salary of 4,380 euros per month or 52,560 euros per year (limit applies to the whole of Germany) The amount of the minimum salary is published each year by the Federal Ministry of the Interior and Home Affairs in the Federal Gazette by December 31 of the previous year (see further information).
- You can continue to secure your livelihood and health insurance coverage independently without drawing on public benefits.
- The approval of the Federal Employment Agency for taking up work has been obtained or renewed (approval is usually obtained from the Foreigners' Registration Office). For the approval, among other things, your working conditions (especially salary) must be comparable to those of a German employee in the same position.

Verfahrensablauf

You must apply for the extension of your residence permit at the aliens' registration office responsible for your place of residence. The procedure is as follows:

- Depending on the foreigners authority and your concerns, it may be possible to apply via the Internet.

Find out whether your foreigners authority offers electronic application for the residence permit.

- If the application is only possible in person, make an appointment with the Aliens' Registration Office. During the appointment, your application will be received and your supporting documents will be checked (bring them with you to the appointment). For the renewal of the electronic residence permit (eAT card) your fingerprints will be taken.
- In the case of an electronic application, the Aliens' Registration Office will contact you after receiving your application to schedule an appointment at the Aliens' Registration Office. During the appointment, your supporting documents will be checked (bring them with you to the appointment) and your fingerprints will be taken for the renewal of the electronic residence permit (eAT card).
- If your application is granted, the Aliens' Registration Office will arrange for the eAT card to be produced.
- After about six to eight weeks, you can pick up the eAT card at the Aliens' Registration Office.
- The eAT card must always be collected in person.
- There are fees for the extension of the residence permit. The timing and form of payment vary depending on the authority.

Frist

- The extension should be applied for at least eight weeks before your valid residence permit expires.
- In case of extension, the new residence permit will be issued again for a limited period of time. The validity depends on the period of validity of your employment contract and the approval of the Federal Employment Agency.

An appeal against the decision of the Foreigners' Registration Office may be filed with the court specified in the decision.

employment Extension for the purpose of employment with distinctive practical professional knowledge

- The residence permit for foreign IT specialists for the purpose of employment with distinct practical professional knowledge can be extended if the residence permit expires and the employment is to be continued.

- The extension must be applied for at least eight weeks before the expiry of the temporary residence permit.

- The same conditions apply to the extension as to the granting.

- If the period of validity of the approval obtained when the residence permit was issued has expired, the approval of the Federal Employment Agency must be obtained again.

- If the obligation to attend an integration course was stated when the residence permit was issued, proof must be provided that the obligation has been fulfilled. If the integration course has not yet been completed, the Foreigners' Registration Office can refuse the extension or extend the residence permit for only one year until the course has been successfully completed or proof has been provided that integration into social life has taken place in another way.

- In the course of the extension, the residence permit is limited again.

- An extension is excluded if this was already ruled out by the foreigners authority when the permit was issued or the last extension.

- Depending on the foreigners authority and the request, the application is possible via the Internet or in person.

- Fees: For a further stay of up to three months: EUR 96.00 for a further stay of more than three months: EUR 93.00 Under certain conditions a fee reduction or fee exemption can be considered.

- Responsible: the foreigners authority responsible for the applicant's place of residence.
