The obligation to have a driver card applies to:</p> <ul style="list-style-type: none"> • Motor vehicles with a maximum permissible mass of more than 3.5 t including trailers, • motor vehicles with a maximum permissible mass of 2.8 to 3.5 t including trailers, provided that a digital tachograph is installed, • as well as for motor vehicles designed for the transport of more than nine persons including the driver. <p>Exemptions result from § 1 paragraph 2 and § 18 of the Driving Personnel Ordinance as well as Article 3 of Regulation (EC) No. 561/2006.</p>
