Teaser	If your total income has decreased or your rent burden or the number of household members has increased, you can apply for an increase in housing benefit.
Volltext	<p>If you are currently receiving housing benefit, you can apply for higher housing benefit as a subsidy towards your housing costs if</p> <ul style="list-style-type: none"> <li>• your total income has decreased,</li> <li>• the number of household members to be taken into account has increased or</li> <li>• your rent or housing costs have increased.</li> </ul> <p>These changes can, but do not necessarily have to, lead to an increase in housing benefit.</p>
Erforderliche Unterlagen	<p>In addition to the application form to be completed (application for an increase), you must also submit further documents as proof (of the changes that have occurred). Further documents may include in particular</p> <ul style="list-style-type: none"> <li>• Proof of income (salary certificate, pension statement, etc.),</li> <li>• Documents relating to the rent increase,</li> <li>• Documents on the encumbrance of the residential property you use, if you are its owner.</li> <li>• Proof of any changes to the household members to be taken into account.</li> </ul> <p>Please refer to the application form or the information provided by your local housing benefit office to find out which documents you need to submit in your</p>

Voraussetzungen	<p>Prerequisites for an increase in housing benefit:</p> <ul style="list-style-type: none"> <li>• a reduction in total income of more than 10%,</li> <li>• an increase in the number of household members to be taken into account,</li> <li>• an increase of more than 10% in the rent or charges to be taken into account less the amounts for relief on heating costs.</li> </ul>
Kosten	There are no fees.
Verfahrensablauf	<p>In order to receive a higher housing benefit, you must submit an application for an increase to your local housing benefit authority.</p> <p>Once the application has been processed, you will receive a notification from there.</p>
Bearbeitungsdauer	
Frist	The increase takes effect from the month in which the application is submitted. A retroactive increase in housing benefit is generally not possible.
weiterführende Informationen	
Hinweise	<p>If your financial situation or living circumstances have improved or changed, this may also lead to a reduction in housing benefit. Rechtsbehelf	<p>After you have applied for an increase in housing benefit, you will receive a decision from your housing benefit authority. If you feel that your rights have been infringed by this decision, you can lodge an appeal against it.</p> <p>If you intend to lodge an appeal against the decision of the housing benefit authority, you must do so within one month of being notified of the decision.</p> <p>The same applies if you wish to appeal against the decision.</p> <p>You will find all the necessary information in the information on legal remedies at the end of the notice.</p>
Kurztext	<ul style="list-style-type: none"> <li>• Approval of an increase in housing benefit</li> <li>• An application for an increase in housing benefit can be made if the total income is reduced, the rent/burden is increased or the number of household members to be taken into account is increased.</li> <li>• The housing benefit authorities are responsible</li> </ul>
Ansprechpunkt	<p>Contact the housing benefit authority responsible for you.</p>
