Teaser	After successful completion of your training in Germany, your residence permit can be extended for a maximum of 12 months in order to look for a job.
Volltext	<p>If you have successfully completed school or company training in Germany, you can be granted a residence permit to look for a job.</p> <p>The residence permit will be issued for a limited period of time directly following your previous training. An extension is possible if the maximum period of 12 months was not utilized when the permit was first issued. If you do not find a job during this period, an extension is also excluded. You are then obliged to leave the Federal territory.</p> <p>The aim of the search can also be self-employment. The residence permit allows unrestricted gainful employment.</p>

- 1 current biometric photo

Voraussetzungen

- You have a recognized and valid passport or passport substitute as well as a valid residence permit for the purpose of seeking employment after successfully completing school or company training in Germany.
- The maximum period of 12 months has not yet been exhausted.
- The period of validity of your residence permit will expire in the near future.
- There is no interest in deportation against you.
- Your stay does not endanger or impair the interests of the Federal Republic of Germany.
- Your livelihood is secured.
- Your identity has been clarified.

Gebühr: 93€
Extension of residence permit for job search after vocational training for a further stay of more than three months
Under certain circumstances, a fee reduction or fee waiver may be considered.

Verfahrensablauf

The extension of your residence permit must be applied for at the aliens' registration office responsible for your place of residence.

- Depending on the foreigners authority and your request, it may be possible to apply via the Internet. Find out whether your foreigners authority offers electronic application for the residence permit.
- If the application is only possible in person, arrange an appointment with the Aliens' Registration Office.

- During the appointment, your application will be received and your supporting documents will be reviewed (please bring them with you to the appointment). Your fingerprints will be taken for the issuance of the electronic residence permit (eAT card).
- In the case of an electronic application, the Aliens' Registration Office will contact you after receiving your online application to arrange an appointment at the Aliens' Registration Office. During the appointment, your supporting documents will be checked (please bring them to the appointment) and your fingerprints will be taken for the issuance of the eAT card.
- If your application is approved, the Aliens' Registration Office will arrange for the eAT card to be produced.
- After about six to eight weeks, you can pick up the eAT card at the Aliens' Registration Office.

There are fees for the extension of the residence permit. The timing as well as the form of payment varies depending on the authority.

Frist

- Extension of the residence permit: at the latest eight weeks before the expiry of your still valid residence permit.
- The residence permit is limited to 12 months including any extension.
- Period of action: 1 month

Rechtsbehelf

An appeal against the decision of the Foreigners' Registration Office may be filed with the court specified in the decision.

Kurztext

- Residence permit for the purpose of gainful employment Extension for job search after school or company training.
- Residence permit for the purpose of job search can be extended if its period of validity expires in the near future, but the search for a job has not yet been successful.
- The extension must be applied for at least eight

weeks before the expiry of the time limit.

- A residence permit can only be extended if the conditions that existed when it was first issued continue to apply.
- In the case of an extension, the residence permit is again limited in time.
- The extension takes place after successful completion of training for job search for a maximum of 12 months.
- The extension is excluded if such an extension was already excluded by the foreigners authority when the permit was issued or the last extension was issued.
- Depending on the foreigners authority and the request, the application is possible via the Internet or only by means of a personal visit.
- There are fees for the extension. The time as well as the form of payment varies depending on the authority.
- Responsible: the foreigners authority responsible for the applicant's place of residence.
