Teaser	If you need a partial permit for larger facilities whose construction or commissioning extends over a longer period of time, then a partial permit can be applied for.
Volltext	For partial approval of larger plants whose construction or commissioning extends over a longer period of time, you require a partial permit in accordance with Section 8 of the Federal Immission Control Act (BImSchG). A partial permit is possible for: • the construction of a plant, • the construction of a part of the plant or • the construction and operation of a part of the plant.
Erforderliche Unterlagen	Specific information on the required documents is not possible due to the large number. Information on this can be obtained from the responsible office.
Voraussetzungen	• there is a legitimate interest • the licensing requirements for the subject of the partial license applied for are fulfilled • if a preliminary assessment shows that there are no a priori insurmountable obstacles to the construction and operation of the entire facility with regard to the permit requirements
Kosten	The fees are based on No. 2.1.2 of the Thuringian Administrative Costs Ordinance for the Business Division of the Ministry for the Environment, Energy and Nature Conservation (ThürVwKostOMUEN) of 14.10.2011. The amount of the fees depends on the investment costs. This does not include the costs of
