Volltext	Before applying for a permit under the Federal Immission Control Act, you can submit an application for a preliminary decision. The preliminary decision is primarily used to clarify important questions about individual approval requirements in advance in the case of complex or new types of plant. These include questions such as whether the project is permissible at the intended location or whether the technical implementation ensures that no harmful effects on the environment are caused.
Erforderliche Unterlagen	Specific information on the required documents is not possible due to the large number. Information on this can be obtained from the responsible office.
Voraussetzungen	• The effects of the planned plant can be sufficiently assessed. • You can demonstrate a legitimate interest in the issuance of a preliminary decision.
Kosten	The fees are based on No. 2.2 of the Thuringian Administrative Costs Ordinance for the Business Division of the Ministry for the Environment, Energy and Nature Conservation (ThürVwKostOMUEN) of 14.10.2011.
