Volltext	A custody register is kept at the responsible youth welfare office for children of parents who are not married to each other. Entries are made in this custody register when: • custody declarations are made, • custody has been jointly transferred in whole or in part on the basis of a legally binding court decision • custody has been wholly or partially withdrawn from the mother or transferred to the father on the basis of a final court decision. A mother who is not married to the father of the child may obtain a certificate stating that and to what extent she is the holder of parental custody of her child.

Voraussetzungen	• Date of birth of the child • Place of birth of the child • Name of the child, which he/she had at the moment of the birth registration
