You can register your children for after-school care before and/or after school and also during school vacations. If your children attend primary school (1st to 4th grade), they are entitled to after-school care on all school days (Mondays to Fridays) with a daily care time of ten hours, taking into account teaching time, as well as during school vacations. The specific scope of the after-school care and the after-school care offered during school vacations is determined by the school. |

| Frist                        | The application must be submitted in writing annually by May 31 for the following school year.
