Teaser	With the registration certificate part II (formerly vehicle registration document), you can prove that you are authorized to dispose of the vehicle in question.
Volltext	<p>You may only use a vehicle subject to registration on public roads if it has been registered for this purpose by the competent registration authority.</p> <p>The registration certificate part II is proof of the right of disposal, but it is not proof of ownership.</p> <p>It is an EU-wide document.</p> <p>If your vehicle still has an old registration certificate, it remains valid.</p>

Voraussetzungen	<p>The completion of a registration certificate Part II or its first issue by the registration authority is only permitted on presentation of</p> <ol style="list-style-type: none"> <li>1\ the certificate of conformity,</li> <li>2\ the data confirmation or</li> <li>3\ the certificate of individual approval of the vehicle.</li> <li>4\ proof of authorization to dispose of the vehicle: in the case of a new vehicle, this is e.g. the purchase contract, in the case of a used vehicle it would be the previous registration certificate Part II.</li> </ol>
Kosten	A fee is payable for the issue of a registration

	<p>certificate part II.</p> <p>Information on the amount of the fee can be obtained from your local vehicle registration authority.</p>
Verfahrensablauf	<p>In the case of a new vehicle, you will usually receive a pre-filled form of the registration certificate part II from the manufacturer in connection with the purchase of the vehicle.</p> <p>As part of the registration process, the registration certificate part II is issued by the competent authority.</p>
