Teaser	If you have taken delivery of grapes, mash, grape must, partially fermented grape must or young wine, you are obliged to specify the supplier companies and the products taken delivery of in the form of the list of suppliers.

Volltext	If you have taken over grapes, mash, grape must, partially fermented grape must or young wine from a wine-growing business or another business for wine production or for delivery, you must submit a list of suppliers for wine production. You are obliged to report all additions and purchases. This is purely a notification. You will not subsequently receive any notification from the authorities.

Voraussetzungen	You have (for example as a winery or trading company) taken over wine products such as grapes, mash, grape must, partially fermented grape must or young wine for wine production or unaltered sale from a supplier (e.g. winery, winegrower).
Kosten	There are no costs.
Verfahrensablauf	You can report the supplier directory online. • Log in to the online winegrowing service with your access data and call up the supplier directory. • The program will guide you step by step through the required information. • Fill in the input fields online. • At the end of the input masks, you can send the form directly online to the responsible office. Alternatively, you can submit the notification by post, fax or e-mail. • You can obtain the relevant form from the responsible office. • Complete the form and submit it by post or fax by the deadline. Alternatively, you can scan the form and send it to the responsible office by e-mail.

Frist	You must submit the list of suppliers for the wine production declaration by January 15 of the year following the harvest at the latest.
