Teaser	If you want to use the job title "occupational therapist", you need a license.
Volltext	Working as an occupational therapist is regulated in Germany. This means that in order to work as an occupational therapist in Germany, you must apply for a state license. With this permit, you can use the job title "occupational therapist" and thus work in the profession.
Erforderliche Unterlagen	You will need the following documents to process the application: • Proof of the state examination certificate, to confirm that the training period prescribed by the relevant law has been completed and the state examination has been passed or proof of the notice of equivalence of the foreign professional qualification. • Proof of reliability: This is the confirmation that you have not been guilty of any behavior that would make you unreliable to practice the profession. This must be done by submitting an official certificate of good conduct, which must not be older than 3 months when the permit is issued. • Medical certificate stating that you are not medically unfit to exercise the profession, which must not be

	older than 3 months when the permit is issued. • Confirmation that you have the necessary knowledge of the German language to carry out the professional activity (language level B 2).
Voraussetzungen	The license is granted if you • have completed the vocational or higher education training prescribed by law and have passed the state final examination, • have not been guilty of any conduct that makes you unreliable to practise the profession, • are not unfit in health terms to practise the profession, • have the necessary knowledge of the German language to practise the profession.
Kosten	Is based on the respective administrative fee schedule of the federal state or on the fee statutes of the authorities responsible under federal state law.
Verfahrensablauf	You must apply for the permit from the competent authority. Once you have submitted the application and all documents are complete, the competent authority will check whether you meet all the requirements. If you meet all the requirements, you will receive the permit. You may only start working once you have received the permit.
Bearbeitungsdauer	If the documents are complete, your application will be processed promptly.
Frist	There are no deadlines to be observed.
