Teaser	You require a permit exemption if you wish to make changes to buildings and structures that do not require a building permit. You must notify the competent authority of this exemption.
Volltext	If you want to make changes to buildings and structures that do not require a building permit, you need a so-called permit exemption. Once you have obtained this, you must report the exemption to the lower building supervisory authority.
Erforderliche Unterlagen	Application for exemption from approval for changes to buildings and other structures. Please contact the responsible office to find out which other documents you need to submit for the permit exemption for the change of use in the building project.

Kosten	Depending on the chargeable building value in accordance with the administrative cost schedule of the Building Fees Ordinance.
Verfahrensablauf	As the building owner, you must submit the required documents to the municipality. The municipality will immediately submit the documents to the lower building supervisory authority,
