Teaser	<p>Do you have a permit to work with pathogens and now want to take up this activity for the first time? Then you must notify the competent authority of the activity. You can find more information here.</p>
Volltext	<p>The term "pathogens" refers to agents capable of reproduction (viruses, bacteria, fungi, parasites) or other biologically transmissible agents that can cause an infection or a transmissible disease in humans.</p> <p>If you as the responsible person or permit holder intend to take up specific activities with pathogens (permit-free or subject to a permit), you must notify the competent authority.</p> <p>The obligation to notify exists regardless of whether the activities have already been previously notified by another responsible person or permit holder, or whether they are new activities that have not yet been notified. The activity is taken up "for the first time" if the responsible person has never previously worked with the specific pathogen.</p> <p>There is no obligation to notify employees who work under the supervision of a person who has the required permit for activities involving pathogens.</p> <p>Activities involving pathogens include in particular</p> <ul style="list-style-type: none"> <li>• Experiments with pathogens capable of reproduction,</li> <li>• microbiological tests and methods for the detection of pathogens subject to mandatory reporting,</li> <li>• targeted enrichment or multiplication of pathogens,</li> </ul>

Important:

Even if you do not require a permit but carry out activities involving pathogens, you must report this.

## Erforderliche Unterlagen

- Certified copy of the permit in accordance with the Infection Protection Act (if this was issued by another authority) or information on exemption from the permit within the meaning of the Infection Protection Act
- Information on the nature and scope of the intended activities and disposal measures: Listing or naming of the pathogens in accordance with the Infection Protection Act and classification of the pathogens (biological agents) in risk groups in accordance with the Biological Agents Ordinance Presentation of the disposal routes and disposal procedures for infectious waste in accordance with "Protective measures for activities involving biological agents in laboratories" and "Guidelines for the treatment, inactivation and testing of waste".
- Information on the condition of the rooms and facilities: Submission of the floor plan with functional designation of the rooms, i.e. designation of the floor, representation of the access routes, designation of the laboratory rooms for microbiological work, description of the function of the laboratory rooms. Description of the demarcation to other areas in which no activities involving biological agents of the specified risk group are carried out. Risk assessment and assignment of the activities to a protection level in accordance with the Biological Agents Ordinance. Description of the room equipment and room layout. A detailed description of the work rooms is required, in particular a description of the surfaces, laboratory tables, installations, ventilation systems, windows, desks. Description of the supply and disposal areas, the ancillary rooms, any animal stalls and the technical equipment. Compilation of a list of laboratory equipment with location details, in particular a description of the steam sterilizer used for the disposal of biological agents. Information on maintenance, effectiveness checks and description of

the waste containers for the disposal of microbiological waste.

- Description of the protective measures: Evidence of protective measures for targeted and non-targeted activities involving biological agents in laboratories in accordance with the "Technical Rules for Biological Agents". Presentation of the labeling of workplaces, in particular the installation of doors, collection containers and furnishings with the biohazard symbol in accordance with "Biological Agents Ordinance Annex I" or DIN standard "Medical-microbiological laboratories; safety labeling".
- Submission of the operating instructions in accordance with the Biological Agents Ordinance and DIN standard "Medical-microbiological laboratories; requirements for the organizational plan"
- Submission of the hygiene plan in accordance with the "Technical Rule for Biological Agents" and DIN standard "Medical-microbiological laboratories; requirements for the hygiene plan")
- Information on the presence of an animal house

**Voraussetzungen**

- Permit or exemption in accordance with the Infection Protection Act
- There is no risk to public health. In particular suitable rooms or facilities must be available for the type and scope of the activities and the conditions for safe disposal must be met.

**Kosten**

The fees are based on the time spent and any expenses incurred.

**Verfahrensablauf**

You must submit the notification to the competent authority at least 30 days before you intend to start work.

The authority will check your documents and carry out an on-site inspection if necessary.

**Bearbeitungsdauer**

30 days after submission of the complete documents.

**Frist**

The activity must be notified at least 30 days before the intended commencement of activities. The activity may only commence if the notification is complete and the activity is not prohibited after examination of the documents and the premises.
