Teaser	If your registration documents are lost or stolen, you must apply for a replacement.
Volltext	If your individual operating license for a vehicle without registration has been lost or stolen, you must be issued with a new operating license. In the event of theft, you must immediately file a theft report with the police. A registration certificate Part I and Part II belong to a motor vehicle or trailer, and an operating license/COC document for vehicles without registration. If any of these are lost or stolen, you must report this immediately to your local registration authority and

Verfahrensablauf	If the technical data for the vehicle is already stored at the registration office of the district, a replacement document can be issued to you immediately. If the technical data for the vehicle is not stored, a clearance certificate must be applied for at the registration office. The clearance certificate must then be submitted to the manufacturer, who can issue a replacement type approval. If the manufacturer no longer exists or the vehicle was manufactured in-house, the clearance certificate must be submitted to a testing organization. The testing organization will issue a technical report. The registration office can issue the replacement type approval on the basis of the test organization's report.

Hinweise	If you find the registration document or operating license you thought you had lost after the replacement document has been issued, you must return the old document to the registration authority as soon as possible.
Rechtsbehelf	
Kurztext	<ul> <li>Operation of vehicles without registration Permit replacement after notification of loss</li> <li>If the operating permit (individual operating permit) of a vehicle without registration has been lost or stolen, a new operating permit must be issued.</li> <li>In the event of theft, a theft report must be filed with the police immediately.</li> <li>In the case of vehicles without registration, this is an operating license/the COC document.</li> <li>The loss must be reported immediately to the**** local registration authority and a new registration certificate or operating license must be applied for.</li> <li>In some cases, the registration authority will also require you to submit a sworn statement about the loss of the vehicle document.</li> <li>If the technical data for the vehicle is not stored, a clearance certificate must be applied for at the registration office.</li> <li>The clearance certificate must then be submitted to the manufacturer, who can issue a replacement type approval.</li> <li>If the manufacturer no longer exists or the vehicle was manufactured in-house, the clearance certificate must be submitted to a testing organization.</li> <li>Required documents:</li> <li>Valid identity card or passport</li> <li>for commercially used vehicles: additional appropriate proof</li> <li>in the event of loss or affidavit or police report of loss</li> <li>ID document of the person(s) responsible</li> <li>Possibly a confirmation from the vehicle owner</li> <li>in the event of loss by associations/companies:</li> </ul>
