Teaser	You would like to report a retraining measure and have it checked by the responsible office.
Volltext	<p>Retraining is used for professional reorientation, usually because the previous profession can no longer be practiced. They are usually carried out on the basis of recognized training occupations and must therefore be monitored by the bodies responsible for these occupations (e.g. chambers of industry and commerce, chambers of crafts). As the person undergoing retraining (not the person undergoing retraining, but the organization providing the retraining), you are therefore obliged to notify the relevant competent body of the retraining.</p> <p>The obligation to notify extends to the essential content of the retraining contract. When concluding a retraining contract, a copy of the contract must be enclosed.</p>
