Volltext	If you have a foreign driving license for motor vehicles, you can have it rewritten for Germany. Under which conditions the foreign driving license is rewritten depends on whether it is a driving license of the EU/EEA states or of a third country. Holders of driving licenses legally issued outside the EU/EEA may continue to use them for a period of 6 months after establishing normal residence in Germany. To apply for the transfer, you must appear in person at the driver's license office.
