Teaser	If you want to work as a driving instructor, you need a driving instructor's license. This must be applied for at the responsible office.
Volltext	Anyone who trains persons who wish to obtain a permit to drive motor vehicles (learner drivers) requires a driving instructor's permit. The driving instructor permit is issued upon application in the BE class and additionally in the A, CE and DE classes.
Erforderliche Unterlagen	In order to obtain a driving instructor's license, a written application indicating the desired class must be submitted to the Driving License Authority. In addition, the following must be enclosed with the application • official proof of place and date of birth • curriculum vitae with handwritten signature • a medical certificate of mental and physical fitness • a certificate or an expert opinion on the fulfillment of the requirements for physical and mental fitness required of applicants for a category C1 driver's license and a certificate or an expert opinion on the fulfillment of the requirements for eyesight required of applicants for a category C1 driver's license, which are not older than one year at the time the application is submitted • a copy of the card driver's license issued after January 1, 1999; it must be officially certified if the driver's

	 license is not presented for inspection, a proof of the required previous education, a certificate of good conduct, document type 0, for presentation to the licensing authority, a certificate from the officially recognized driving instructor training center on the duration of the training carried out

Kosten	The fees are levied on the basis of Section D of the Annex to the Schedule of Fees for Road Traffic Measures.
Verfahrensablauf	Training as a driving instructor can only take place in one of the approximately 56 recognized driving instructor training centers nationwide. This involves not only theoretical training, but also an internship at a training driving school. Applicants for a driving instructor's license for class BE (driving instructor candidates) are granted a candidate authorization for the purpose of further training and examination in accordance with §§ 7, 8 of the Driving Instructor Act, insofar as this extends to the teaching

	tests in theoretical and practical driving instruction, if the practical driving test and the specialist knowledge test have each been successfully passed. The candidate authorization expires either when the unlimited driving instructor authorization is granted or after three unsuccessful teaching tests in theoretical or practical driving instruction or after 2 years from the date of granting.

Hinweise	Applicants who have already obtained a driving instructor's license in the public service (German armed forces, police) and are seeking a civilian driving instructor's license do not need to take the driving instructor's test. In addition to the above-mentioned documents, these applicants must enclose proof of possession of the official driving instructor's license (e.g. a certified copy of the driving instructor's license) with the application. Persons who have acquired an authorization to train learner drivers in other European countries may be granted a corresponding German driving instructor's license under simplified conditions (§§ 3 and 5 FahrIG).
