Volltext	If a partnership company wishes to establish itself permanently in Thuringia and use the professional designations "architect", "interior architect", "landscape architect" or "urban planner" as well as the addition "freelance" or "freischaffend" in the company name or in the name of the company, it must be registered in the company register of the Chamber of Architects of Thuringia. The registration must be applied for in writing.
Erforderliche Unterlagen	<p>As a rule, the following documents are required:</p> <ul style="list-style-type: none"> <li>• Copy of the Articles of Association / Memorandum and Articles of Association and, if applicable, amendments in certified form.</li> <li>• Copy of the list of shareholders / supervisory board members</li> <li>• Copy of the list of managing directors / board of directors</li> <li>• Copy of the application to the Commercial Register /Partnership Register</li> <li>• Proof of professional liability insurance according to § 33 ThürAIKG</li> <li>• Proof of payment of the registration fee</li> </ul>
Voraussetzungen	<ul style="list-style-type: none"> <li>• registered office or a branch office in Thuringia</li> <li>• at least one partner is a member of the Thuringian Chamber of Architects</li> </ul>

Kosten	<p>For the procedure before the registration committee, the following fees are payable upon filing the application:</p> <ul style="list-style-type: none"> <li>• Registration of a partnership company: EUR 400.00</li> </ul>
Verfahrensablauf	<p>You can submit your application in writing to the Chamber of Architects.</p> <p>The registration committee of the Chamber of Architects will decide on your application.</p>
Bearbeitungsdauer	<p>The Chamber of Architects decides on the application for entry in the register of companies within three months of receipt of the complete documents. The deadline may be extended once by up to one month in individual cases if this is justified due to the specifics of the matter.</p>
Frist	<p>No deadlines need to be observed.</p>

Hinweise	<p>The company does not become a member of the Chamber by registration in the register of companies. Membership fees are not charged.</p>
Rechtsbehelf	<p>Before filing an administrative court action against a decision of the registration committee, the Chamber of Architects does not require a review in preliminary proceedings (opposition proceedings).</p>
